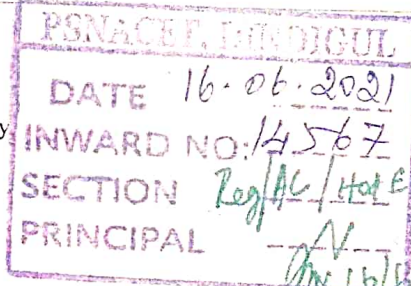

This has reference to your application I.D. No. 3255-09/11/2018 seeking accreditation by National Board of Accreditation to UG Electrical & Electronics Engineering program (Tier II) offered by PSNA College of Engineering and Technology, Kothandaraman Nagar, Muthanampatty, Dindigul- 624 622, Tamil Nadu.

2. An Expert Team conducted on-site evaluation of the program from 13th to 14th March, 2021. The report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. 3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The program has been granted accreditation for 3 years. PSNA College of Engineering and Technology, Kothandaraman Nagar, Muthanampatty, Dindigul- 624 622, Tamil Nadu should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above so as to be eligible for consideration by the concerned Committee in NBA for further processing of the accreditation status.

5. The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to PSNA College of Engineering and Technology, Kothandaraman Nagar, Muthanampatty, Dindigul- 624 622, Tamil Nadu as a whole. As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously. 
